JDD recap

Shop was cleaned by Wednesday and all tables were set up by Thursday afternoon. Saturday Jim opened the shop up for breakfast only to discover water overflowing from the bathroom. Water was in the office as well. The faucet was not turned off all the way and the drain in the restroom was blocked from food causing the water issue. Monday morning was spent cleaning up. Garbage cans were not emptied, debris on the floor, tables and chairs were not taken down.

With the amount of rain before and during JDD the carnival left ruts from the semis that needed to be backfilled. Picnic tables were spread throughout the park.

Mowing continues with all the rain.

City Hall roof drains have been cleared several times due the amount of heavy rains that we have been receiving.

Recycling center white goods, tv's, and appliances that have freon will be getting picked up within the next few weeks. The drive has been smoothed out add gravel.

Potholes at City Hall, Grand St have been filled

Stakes that are placed along Hwy 44 is for sidewalk ramp replacement and/or spot curb and gutter repairs. Inlet repairs or improvements for the 2025 project.

Water/Wastewater

On May 22nd we had lightning take out 2 of our Variable Speed Drives at the treatment plant. I had Ness electric look at them and he determined it was from lightning. A claim was submitted to our insurance and approved. The only cost to us will be the \$1000 deductible. I am asking for approval for the deductible.

On June 4th I had L-R Meter come to test all our large meters which we are required to do every 2 years. The 3 inch meter at the Elementary School is a compound meter from 1994 and is bad. The low flow side of the meter will not read any water from 10 gallons per minute or lower. The majority of the school's water use is low flow so we are losing money. The cost of replacement is \$2,345.00 from Core and Main. We are locked into Sensus meters so there is no other quote. I would like approval to purchase the new meter for the Elementary School.
